PhDr. Magdaléna Nespěšná Hamsíková, PhD. has studied the History of the Arts at the Philosophical faculty of the Charles University in Prague. In 2011 she successfully defended her doctoral thesis „The Acceptance of Works of Lucas Cranach the Elder in Painting of the First Half of the 16th Century in Bohemia“. In 2006 she became an assistant at the Institute of Christian Art at the Catholic Theological faculty of the Charles University in Prague, in 2007 she started her pedagogical career at this Institute. In 2009-2012 Dr. M. Nespěšná Hamsíková worked as an external lectrice in the National gallery in Prague in the Collection of the Medieval Art in Convent od St. Agnes of Bohemia. Among the main fields of the scientific interest of Dr. M. Nespěšná Hamsíková belongs the European painting, sculpture and architecture of the Middle Ages and Renaissance.

In the past PhDr. Magdaléna Nespěšná Hamsíková, PhD. participated in several significant grant projects: GAČR – Gothical Art in the North and North-East Bohemia (2001–2003); Ars Montana: Artistic and Cultural Transfer in the Open Space of the Czech-Saxon Ore Mountains on the Threshold of the Early Modern Age (1459–1620) (2012–2014); Cultural Codes and their Transformations in the Hussite Period (2014–still); NAKI –Artistic Exchange in the Ore Mountains Region between the Gothic and the Renaissance (2012–2015). She participated in the research of the the Catholic Theological faculty of the Charles University in Prague – Czech Lands in the Middle of Europe in the Past and Today. Her long-term professional interest appeared many articles in publications as well as in the monography „Lucas Cranach and the Painting in Czech Lands 1500–1550“ (2016).

Nowadays is Dr. M. Nespěšná Hamsíková working at the Catholic Theological faculty of the Charles University in Prague where she is giving the lectures on Czech and Central European Renaissance.
